## LETTER OF CONSENT

I, \_\_\_\_\_, hereby acknowledge that I have

received and read the **Quebec Midget AAA Hockey League (QMAAAHL) Anti-Doping Policy**. I understand that as a player participating in the **QMAAAHL**, I will be subject to doping control during the LHMAAAQ hockey season and I am personally responsible for adhering to the **QMAAAHL Anti-Doping Policy**.

I understand that in the event I contravene the **QMAAAHL Anti-Doping Policy**, I may be investigated by the Anti-Doping Disciplinary Committee of my League and following that initial investigation, may be sanctioned by the **QMAAAHL** pursuant to the **QMAAAHL Anti-Doping Policy**. These sanctions may include, but are not limited to, a suspension, which will prevent me from playing hockey with my **QMAAAHL** team during the period of the suspension.

I understand that the **Canadian Centre for Ethics in Sport (CCES)** has been granted authority by the **QMAAAHL** to conduct doping control..

### **For Canadian Players only**

I understand that the **Canadian Centre for Ethics in Sport (CCES)** has been granted authority by the **QMAAAHL** to implement the Canadian Anti-Doping Program (CADP) in relation to players participating in the **QMAAAHL**. As a result, as a Canadian player in the **QMAAAHL**, I acknowledge that I am also subject to the CADP and am bound by and must comply with the CADP and the sanctions that may be imposed by the CCES pursuant to the CADP, as specified in the **QMAAAHL** Anti-Doping Policy (article 3.09). Such a sanction could make me ineligible to play hockey outside the **QMAAAHL** for the length of my sanction, if I intend to pursue my hockey career under a program governed by the CADP or with an organization that recognizes a sanction imposed by the CCES. This could prevent me, for example, from representing Canada at international hockey events or participating on a Canadian university varsity hockey team.

### **For non-Canadian Players only**

As a non-Canadian player in the **QMAAAHL**, I may be bound by the anti-doping rules of my National Anti-Doping Organization.

In consideration of the privilege of playing in the Quebec Midget AAA Hockey League, I agree to, acknowledge and accept all of the foregoing.
